All consignment must be clean and in desirable condition and quality for resale. Artiques, LLC reserves the right to accept or decline any consignment item.

Consignors must present photographs of furniture to be approved for consignment, or make an appointment with an Artiques, LLC staff member to visit if the entire contents of the house are to be consigned. Once Artiques, LLC has agreed to accept items on consignment, Consignor will deliver the consigned items at a date and time mutually agreed upon.

Consigned items will be under contract for 60 days from the date they are entered into our system. All items will be catalogued and numbered with a Consignor ID number and stock number. Artiques, LLC is not responsible for the loss, damage, or theft of any consigned item.

Artiques, LLC, agrees to pay the Consignor 40% of the selling price. Should Artiques, LLC need to repair or clean a consigned item, a repair fee will be deducted from the proceeds of the sale. Artiques, LLC prices all items taking into account any paperwork provided and prevailing market demand for each item.

Artiques, LLC will make payments to Consignor once a month if the payment amount is \$75.00 or greater. There will be a \$1.00 check fee assessed for each check issued.

Artiques, LLC may discount an item by 10% during the first 30 days. After 30 days, Artiques, LLC will automatically discount items by 20%. After 60 days, it is the responsibility of the Consignor to contact Artiques, LLC to discuss any unsold items.

Any unsold merchandise may be picked up by the Consignor within 7 days or Artiques, LLC may exercise *either one or both* of the following options as it chooses:

1. Reduce the price of item by 50% with an additional 30 days of contract, OR
2. Donate to a local non-profit organization

If after 80 days from original consignment date Consignor has not contacted Artiques, LLC in regards to unsold merchandise the items will be considered abandoned and become the property of Artiques, LLC.
